# REGULATIONS FOR PARTICIPATION IN THE SCIENTIFIC CONFERENCE

# §1 General Provisions

- These Regulations for Participation define the rules of participation in the scientific conference organized by the Association for Contextual Behavioral Science Polska (ACBS Polska), with its registered office in Wrocław at Plac Solny 16/301, entered into the Register of Entrepreneurs of the National Court Register under number KRS 0000714196, NIP: 7792480627, REGON: 369336487 – hereinafter referred to as the "Organizer".
- 2. These Regulations for Participation are made available to Participants on the website indicated by the Organizer, in a format that allows downloading, saving, and printing.
- 3. Participation in the Conference constitutes acceptance of these Terms and Conditions.
- 4. Only persons aged 18 and over may participate in the Conference.
- 5. The Conference does not constitute a mass event within the meaning of the Polish Act of March 20, 2009 on the safety of mass events.

## §2 Definitions

- 1. **Organizer** ACBS Polska.
- 2. **Conference** the scientific event organized on September 19–21, 2025 at SWPS University, Chodakowska 19/31, 03-815 Warsaw, according to the program published on the Organizer's website.
- 3. **Participant** any adult natural person, legal person, or other organizational unit who has registered for the event.

- 4. **Registration** the act of completing and submitting the online Registration Form.
- 5. **Services** activities of the Organizer related to organizing the Conference, including providing access to lectures, discussion panels, and workshops.

# §3 Registration

- 1. Participation in the Conference requires prior registration through the online form provided by the Organizer.
- 2. A condition for participation is the payment of the conference fee and in the case of using the student discount presentation of a valid student ID.
- 3. By registering, the Participant declares that:
  - a. the data provided in the form is accurate,
  - b. they have read and accept these Terms and Conditions,
  - c. they consent to the processing of personal data to the extent necessary for the organization of the Conference.
- 4. The Organizer is not responsible for incorrect data provided by the Participant or for lack of Internet access that prevents registration.
- 5. The Organizer reserves the right to close registration due to a limited number of places.

# §4 Withdrawal from Participation

1. The Participant acknowledges that the Conference is an educational event taking place on specific dates (September 19–21, 2025), which, in accordance with Article 38(1)(12) of the Polish Consumer Rights Act, excludes the statutory right to withdraw from a distance contract.

# §5 Services

- 1. The Organizer provides the Participant with access to the Conference held on September 19–21, 2025, according to the announced program.
- 2. The Organizer reserves the right to make changes to the program (e.g., change of speakers for reasons beyond their control).
- 3. In the event of a change in the event date due to the Organizer's fault, the Participant has the right to withdraw and receive a refund or transfer participation to another person.

# §6 Liability

- 1. The Organizer make every effort to ensure that the Conference proceeds as planned.
- 2. The Organizer are not responsible for circumstances caused by force majeure, such as a pandemic, government actions, or technical failures.
- 3. The Participant is responsible for the consequences of providing incorrect contact information.
- 4. The Organizer is not liable for the actions of third parties, technical disruptions, or the content delivered by speakers.

#### §7 Order and Conduct

- 1. Participants are required to comply with applicable laws, the provisions of these Terms and Conditions, and the Organizer's instructions.
- 2. Promotional, political, or advertising activities are prohibited without written consent from the Organizer.
- 3. The Organizer reserves the right to exclude from the event any person behaving aggressively, under the influence of drugs or alcohol, or posing a threat to others.

# §8 Copyright

- 1. Materials provided during the Conference, including recordings and presentations, are protected by copyright.
- 2. Any dissemination, copying, or sharing of these materials without the consent of the Organizer or the authors is prohibited.

#### §9 Personal Data

- 2. Personal data will be processed for the following purposes:

  - b. issuing certificates of participation,

- c. sending post-conference materials (e.g., recordings, presentations),
- d. fulfilling tax and reporting obligations.
- 3. With separate consent, personal data may also be used to send information about future events organized by ACBS Polska.
- 4. Providing personal data is voluntary but necessary to participate in the Conference.
- 5. The Participant has the following rights under the GDPR:
  - o the right to access their data,
  - the right to rectification or erasure ("right to be forgotten"),
  - the right to restrict processing,
  - the right to object to processing,
  - o the right to data portability,
  - the right to lodge a complaint with the President of the Personal Data Protection Office.
- 6. Personal data may be entrusted to partners and cooperating entities solely for the purpose of organizing the Conference.

# §10 Complaints

- 1. Complaints regarding participation in the Conference should be submitted via the email address provided by the Organizer.
- 2. Complaints will be reviewed within 14 days of receipt.
- 3. The Participant will be informed of the decision via email.

# §11 Image and Recordings
